FEE -REFUND POLICY:-

At Adhyyan Defence Academy, we understand that unforeseen circumstances can arise that may prevent you from completing your course or attending our classes. We want to make sure that our refund policy is fair and transparent for our students. The system at Adhyyan Defence Academy works in a transparent manner. Our refund policy ensures that all the refunds are processed in a fair manner. In case, where a student expresses his intention of not attending the institute, and withdrawing his admission, he/she will have to visit the institute in person and submit his/her application in writing stating the reason for seeking a refund. The date of submission of written application for refund at the branch/ centre will be considered for the purpose of calculation of the refund amount. Please carefully review the terms and conditions of our refund policy below.

Withdrawal from the course:

If you withdraw from the course before it begins, ₹1000 will be deducted from your tuition fee, and the remaining amount will be refunded. However, if you withdraw from the course after it has begun, the refund will be provided (Refer to annexure: A)

Cancellation of the course:

In the unlikely event that Adhyyan Defence Academy cancels a course, all students enrolled in the course will receive a full refund of their tuition fees.

Refund for absence from class:

If a student is absent from the course for any reason, they are not eligible for a refund of tuition fees.

Refund for suspension or expulsion:

If a student is suspended or expelled from the course due to disciplinary reasons, they are not eligible for a refund of tuition fees.

Refund for medical reasons:

If a student is unable to attend the course due to medical reasons, a partial refund may be granted on a case-by-case basis, provided the student provides a medical certificate as proof.

Refund process:

To request a refund, students must submit a written request to Adhyyan Defence Academy's administration office. The request must include the reason for the refund and supporting documentation where applicable.

Refund timeline:

Refunds will be processed within 30 days of receipt of the written request. The refund will be made to the original payment method used for the tuition fee.

Miscellaneous:

Adhyyan Defence Academy reserves the right to change this refund policy at any time without prior notice. Any changes made to the refund policy will be effective immediately.
